DOMINICAN REPUBLIC

Due to its strategic geographic location, the Dominican Republic has become an important commercial link between Europe, North America, and the rest of Latin America. Its location in the center of the Caribbean, its airports and seaports, make the country the hub of the Caribbean. The Punta Caucedo Port with its 922 Mt. dock, and 13.5 Mt. of depth; Eastern Haina with 1,690Mt. of dock, and 10 Mt. of depth, among others, are catalysts for the growth of trade and the country's exports.

"In February 2017, the United Nations Economic Commission for Latin America and the Caribbean (CEPAL) published its annual report on the economic evolution of Central America and the Dominican Republic, projecting growth of 4.5% on average for the region.

Of all the countries, the Dominican Republic projects the best performance for 2017, with GDP growth to 6.2%, leading above the 6 countries of the Central American sub-region. This is due to its dynamic economic sectors, such as Mining (26.5%), Financial Intermediaries (11.0%), Agriculture (9.6%), Construction (8.8%), Other Services (6.8%), Hotels, Bars and Restaurants (6.4%), Commerce (5.9%), Transportation and Storage (5.3%), Education (5.2%) and Local Manufacturing (4.8%)."

EXPORT LEGISLATION

Law 84-99: For the Reactivation and Fomenting of Exports

-Permits suspension of import levies and taxes on certain goods to be re-exported within an 18-month period.

-The Temporary Admissions Regime allows for the transfer and/or receipt of stored goods and/or manufactured from and to other beneficiary companies, also to and from those under the Free Zones Regime.
